



Tax Residency Self-Certification and Politically Exposed Persons Declarations

Common Reporting Standard (CRS) and Foreign Account Tax Compliance Act (FATCA) Requirements

As part of our regulatory obligations, Mallow Credit Union Ltd is required to collect a tax residency self certification and maintain accurate information regarding the tax residency status of all our members and, where required, report specific account information to the relevant tax authorities. These requirements arise from international tax transparency regulations, specifically the Common Reporting Standard (CRS) and the Foreign Account Tax Compliance Act (FATCA). The objective is to support international efforts to prevent tax evasion and to ensure appropriate tax reporting across jurisdictions.

To comply with these regulations, we kindly ask you to complete the following Tax Residency Self Certification Questionnaire. The information you provide will allow us to correctly identify your tax residency and, where applicable, fulfil our reporting obligations.

4. Politically Exposed Person (PEP) and/or Relative or Close Associate)

A PEP is defined as an individual who is, or has at any time in the preceding 12 months, been entrusted with a prominent public function and includes following roles:

- a head of state, head of government, government minister or deputy or assistant government minister
- a member of a parliament
- a member of the governing body of a political party
- a member of a supreme court, constitutional court or other high level judicial body whose decisions, other than in exceptional circumstances, are not subject to further appeal



- a member of a court of auditors or of the board of a central bank
- an ambassador, chargé d'affaires or high-ranking officer in the armed forces
- a director, deputy director or member of the board of, or person performing the equivalent function in relation to, an international organisation
- a member of the administrative, management or supervisory body of a state-owned enterprise.

The definition of a PEP is also extended to include Relative or Close Associate (RCA) of a PEP. Family members include spouses, partners, parents, siblings, children, and any partner or spouse of the child(ren). Close associates include individuals who have joint beneficial ownership of a legal entity with a PEP, those with sole beneficial ownership of a legal entity established for the PEP's actual benefit, and individuals who are publicly known to have a close personal or professional relationship with the PEP.
